## Board Meeting, December 13, 2011

The meeting started at approximately 6:45PM. In attendance at tonight's board meeting were Lions Dave Aldrich, Ron Niemaszyk, Greg Andejas, Barb Scalet, Kristen Bonham, Bill Lussow, PDG Bill Jordan, Mike Clements and club members, Linda McGill and Carl Scalet.

PDG Lion Bill J. brought to the board's attention that the Arlington Care's foundation is not up to date with reports to the federal and state regulators. He stated we should hold off on giving them our donation until they become recognized in good standing. He also motioned that due diligence be done to make sure the charities we are funding are up to date in their reports to various regulators. Motion passed.

The bingo project was discussed. Lion Greg reported that bingo is beginning to show a profit.

PDG Lion Bill J. handed out a few bingo session reports for the board to review. We went over them and much discussion was had over the way he showed the difference in how the profits and losses were tabulated, with costs of rent, computer rentals, and miscellaneous expenses presented. Lion Ron mentioned the upcoming District convention and is looking to again share the room table with the Palatine Club. He reported that they have not yet responded with their decision.
